

DAVID JONES PEARL EXPEDITIONS PROMOTION TERMS AND CONDITIONS – May 2026

1. This competition is a free game of chance conducted to promote Pearl Expeditions services and winners will be determined by random draw. Instructions on how to enter and details of the prize form part of these Terms and Conditions. Participation in this competition is deemed to be acceptance of these Terms and Conditions.

2. Promoter: The Promoter is Pearl Expeditions Pty Ltd (ABN 79 685 395 493) of Level 1, 2 Martin Place, Sydney, NSW 2000 and the competition is being conducted by David Jones on behalf of Pearl Expeditions. 3. Permit Numbers: Pearl Expeditions is authorised to conduct the game of chance under NSW Permit Number: NSW TP/05102, ACT TP 26/01193 and SA Permit Number T26/849.
